## **CIR: BUYBACK OF SHARES**

*Milan, January* 12 2015 – Under the authorization approved by the Shareholders' Meeting of June 30 2014 and in implementation of the notice published on October 27, CIR–Compagnie Industriali Riunite S.p.A. announces that between January 5 and January 9 2015 it bought back 1,265,457 of its own shares at an average price of  $\notin$  0.8868, for a total amount of  $\notin$  1,122,242.24.
